The *Special Trade System* is used when the statistical territory comprises only a particular part of the economic territory within which goods may be disposed without customs restriction (free circulation area).

Imports include all goods entering the free circulation area of a compiling country, which means cleared through customs for home use; and exports include all goods leaving the free circulation area. However, goods entering and goods leaving an industrial free zone are not recorded since they have not been cleared through customs for home use. The products processed in free zones are also excluded from exports.
