## 995<sup>th</sup> Plenary Meeting

#### Subtheme 3 - UNCTAD, the UN reform process, and development

The interactive session on the theme "UNCTAD, the UN reform process, and development" took place with the participation of the following lead discussants: H.E. Ms. Faiyza Abou El Naga, Minister of International Cooperation for Development of Egypt; and H.E. Mr. Fisseha Yimer, Ambassador, Permanent Representative of Ethiopia to the United Nations in Geneva

During the interactive debate, the following countries took the floor: Canada; Finland (on behalf of the European Union and the acceding countries of Bulgaria and Romania); Argentina; Philippines; Islamic Republic of Iran; India; Benin (on behalf of LDCs); Indonesia; Djibouti; Norway; Afghanistan; Pakistan. The lead discussants responded to issues raised by delegations. Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made comments. H.E. Mr. Gyan Chandra Acharya, President of the Board, made closing remarks.

In the afternoon session, the following representatives made general statements: Argentina (on behalf of the Latin American and Caribbean Group); Angola (on behalf of the African Group); and Afghanistan (on behalf of the Asian Group and China).
