

The document will comprise the strategic framework for the biennium 2012–2013 that has been approved by the Committee for Programme and Coordination (CPC), and the secretariat's proposed programme of work. The focus of this session of the Working Party will be to review the proposed performance measures and the list of outputs for the biennium 2012–2013.
