# I. Agreed conclusions adopted by the Working Party at its fifty-seventh session

## Review of the programme narrative component of the draft proposed programme budget for the biennium 2012–2013

(Agenda item 3)

The Working Party on the Strategic Framework and the Programme Budget,

*Having considered* the draft proposed programme narrative for UNCTAD for the biennium 2012–2013,

1. *Concurs* with the proposed programme narrative for UNCTAD for the biennium 2012–2013 as contained in document TD/B/WP(57)/CRP.1/Rev.1;

2. *Recommends* to the Secretary-General of UNCTAD that he take full account of document TD/B/WP(57)/CRP.1/Rev.1 for the purposes of his submission of UNCTAD's 2012–2013 proposed programme narrative to the Secretary-General of the United Nations;

3. *Recalls* the global economic situation, and emphasizes that particular attention should be given to using resources efficiently and effectively;

4. *Underscores* the importance of the full implementation by the Secretary-General of UNCTAD of the outcomes of the Accra Accord implementation review;

5. *Emphasizes* the importance of rapidly improving the operation of the Special Unit on Commodities;

6. Recalling the Accra Accord and the relevant agreed conclusions of the Working Party, in which UNCTAD has been requested to intensify assistance to the Palestinian people, *reaffirms* that adequate resources should be provided to UNCTAD's programme of assistance to the Palestinian people to alleviate their adverse economic and social situation and assist in the State-building process;

7. *Recalls* previous Trade and Development Board decisions and Working Party agreed conclusions to enhance resources for the Division for Africa, Least Developed Countries and Special Programmes; expresses deep concern that despite these decisions and conclusions, the resources within the Division remain seriously inadequate, which has been seriously impeding the work of the Division, therefore reiterates its request to consider this issue on a priority basis to ensure that the Division concerned is provided with adequate resources to carry out its mandated activities;

8. *Requests* the Secretary-General of UNCTAD to ensure that adequate provisions are made to carry out the mandated activities of UNCTAD to follow up on the UNLDC-IV outcomes;

9. *Expresses concern* at the delays in filling vacant posts, particularly at the senior level, and strongly reiterates its request that these posts be filled at the earliest possible opportunity;

10. *Requests* the Secretary-General of UNCTAD to keep member States regularly informed on the geographical distribution, names, positions, nationality, grade and gender balance of staff;

11. *Recalls* UNCTAD's mandate on promoting full and productive employment as contained in paragraph 37 of the Accra Accord, considers that UNCTAD's mandate

should be scrupulously respected at all levels, and requests that these views be communicated to the appropriate body of the General Assembly;

12. *Takes note* of the streamlining of UNCTAD's publications programme for the biennium 2012–2013, stresses that UNCTAD's research and analysis should continue to cover the full scope of issues of concern for developing countries within the Accra Accord, and emphasizes that the impact and dissemination of UNCTAD's research and analysis should be further enhanced;

13. *Requests* the Secretary-General of UNCTAD to further intensify UNCTAD's technical cooperation and to develop a well-defined fund-raising policy in order to obtain sufficient funding and to enhance transparency in and coherence between fund-raising and the needs and priorities of the various divisions of UNCTAD as decided by the member States.

### II. Chair's summary

#### A. Proceedings

1. The fifty-seventh session of the Working Party on the Strategic Framework and the Programme Budget was held in Geneva, Switzerland, on 22–24 November and 2 December 2010, to consider the programme narrative component of the draft proposed programme budget for the biennium 2012–2013.

#### **B.** Opening statements

2. The following speakers made opening statements: Mr. Heiner Flassbeck, Director, Division on Globalization and Development Strategies, on behalf of the Deputy Secretary-General of UNCTAD; the representative of Cuba on behalf of the Group of 77 and China; the representative of Egypt on behalf of the African Group; the representative of Bangladesh on behalf of the Asian Group; the representative of Chile on behalf of the Group of Latin American and Caribbean Countries (GRULAC); the representative of Belgium on behalf of the European Union; and the representative of Nepal on behalf of the Group of Least Developed Countries.

#### C. Informal meetings

3. The Working Party pursued its deliberations in an informal setting.
