II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1 - Election of officers

Under rule 64, paragraph 3, of the rules of procedure of the Trade and Development Board, and in accordance with the cycle of rotation for the election of the Chairman and Vice-Chairman-cum-Rapporteur, the Chairman of the Working Party at its twenty-eighth session shall be a representative of one of the States members in List A (Asia). The Vice-Chairman-cum-Rapporteur, shall be a representative of one of the States members in list A (Africa).

Item 2 - Adoption of the agenda and organization of work

- 2. The provisional agenda for the twenty-eighth session of the Working Party, as reproduced in section I above, was approved by the Working Party at its 113th meeting, on 19 June 1996. A note on the organization of work of the session will be circulated at the opening of the meeting.

The revised work programme narrative proposed by the secretariat is based on the reorientations resulting from decisions of the ninth session of the Conference and in the light of the restructuring of the UNCTAD secretariat.
