Having considered the evaluation report on the TRAINFORTRADE Programme, a scontained in document TD/B/WP/103,

- 1. Takes note with appreciation of the evaluation report;
- 2. <u>Reaffirms</u> the importance it attaches to hum an resources development and to UNCTAD's role in this respect, in accordance with the Midrand Declaration, and invites the Secretary-General of UNCTAD to pursue his efforts to reinforce thes eactivities;
- 3. Recognises the expertise and the comparative advantage of UNCTAD in this area;
- 4. <u>Welcomes</u> the measures being taken by the Se cretary-General of UNCTAD to strengthen the TRAINFORTRADE Programme and <u>invites</u> him to take into consideration in this process the conclusions and recommendations contained in the evaluatio report and to submit a progress report to the Working Party in 1998;
- 5. <u>Further welcomes</u> the statement made by the secretariat concerning the increase in the resources to be allocated to the Programme, includin g regular budget resources;
- 6. <u>Invites</u> donor Governments and institutions to increase theirr contribution to the Programme;
 - 7. Stresses the importance of:

Accurate needs assessment;

The improved sust ainability of the Programme at national, subregional and regional levels;

Proper selection of national institutions, through consultations, in the design and implementation of specific perojects, taking into account the offers made by some institutions in this regard;

- 8. <u>Notes with appreciation</u> the results achieved so far by the Programme and urges the Secretary-General of UNCTAD to enhance the implementation of the projects, including with respect to their follow-up and management;
- 9. <u>Welcomes</u> the measures being taken by the secretariat in usin g information technologies within TRAINFORTRADE, which should maximize the geographical reach of the Programme;
- 10. <u>Recognises</u> the desirability of moving towar ds the creation of generally acceptable diplomas, once the basic preconditions are met, in particular in terms of internal quality control;
- 11. <u>Stresses</u> the need for regular monitoring of the Programme, as well as for its evaluation at shorter intervals;
- 12. <u>Emphasises</u> the need for regular consultations among donors beneficiaries and the secretariat on TRAINFORTRADE;
- 13. <u>Takes note with appreciation</u> of the enhance d cooperation between UNCTAD and other organizations, in particular ITC and WTO, in the implementation of th TRAINFORTRADE Programme and <u>encourages</u> the secretariat to continue and increase its efforts in this direction in order to promote coherence and complementarity;
- 14. <u>Notes</u> the very use ful format of this type of evaluation and <u>encourages</u> the secretariat to use it in future.
